OPERATING INSTRUCTIONS

Already in the past editions of Milano Unica, the **Creative and Sustainable samples** have been <u>integrated into a single space</u> within the Area Tendenze, the heart of the industry's excellence.

PARTICIPATION CRITERIA

To participate in the selection it is necessary to fill out the Participation Form for the **Sustainable Creativity** project, which can be accessed by clicking on the link included in the email.

The Form includes two sections:

1. Personal Data

The Company data entered for the registration with **Milano Unica** are retrieved automatically. If not already available, specify the contact info of the Sustainability Manager.

Creative and NOT Sustainable Samples

Creative and Not Sustainable Samples can be sent in a separate envelope, using the label downloadable from this LINK, to the address specified on page 3.

ATTENTION: if your products do not meet the Sustainability requirements, the procedure ends here.

2. Creative and Sustainable Samples

This section is dedicated to the upload of the product cards and certifications relating to the Creative and Sustainable Samples.

Product Cards and Certifications

Each sample/code/variant presented for admission must be accompanied by a card. The cards must contain all the technical specifications regarding the sample, including any certification obtained.

After completion of the procedure, you will receive a confirmation email with the product cards in PDF format in attachment, containing the information uploaded on the Participation Form.



The product cards must be printed out and attached to the samples before shipping.

If this documentation is not available, the corresponding product samples will not be accepted for inclusion in the project.

ATTENTION: any information provided may become of public domain – entirely or partially – and be disseminated through the communication channels used by **Milano Unica** to promote and increase the visibility of the **Tendenze and Sustainability project.**

TIMING AND SAMPLE SHIPMENT CRITERIA

The samples to be shipped must comply with the following requirements:

- Fabrics: max 20 samples, 50 cm full width
- **Accessories**: max 20 samples (buttons, if too small, will be counted as family groups of the same type)

In order to avoid any problems and complaints, each product sample must bear 2 labels on each extremity indicating:

- · Company Name
- Front/back of the fabric
- Warp/weft direction
- In case of double face fabrics, specify the side to be displayed.

As to Sustainable samples, each shipment must be organized so that <u>each sample</u> <u>always comes with a corresponding product card in pdf format in</u> <u>attachment</u>, compiled based on the relevant Participation Form.

Exhibitors are directly responsible for making their samples clearly traceable in relation to the corresponding reference product code.

All fabrics and accessories will be submitted to the Technical Committee for analysis of the relevant Sustainability requirements and, subsequently, to the Style Committee for verification that the selected materials are in line with the A/W 2021/22 Tendenze. The eligibility of the samples to the **Tendenze and Sustainability project** will be independently and irrevocably decided upon by the two Committees.
